Bidding is open to all eligible bidders as per Section V of Bidding Document
2. Melauli Municipality invites electronic bids from eligible bidders for the construction of Melauli Mandir Jane Bato, Mandir Park Nirman Tatha Parisar Gherparkhal Nirman under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: 70000000
Minimum Work experience of similar size and nature: 3
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
